### Regular Board Meeting

# **Administrative Report**

- a. Ryan Purdy and Mike Steele of Mid Plains Community College were present to share information and opportunities related to MPCC.
- b. Mrs. Rodocker and Mr. Hafer presented the current working draft of the HS class schedule for questions and discussion.
- c. Mrs. Rodocker explained the rationale for needing a semester based report card with progress reports rather than the current quarter based system.
- d. The board was updated on the progress related to replacing the SW route suburban.
- e. Mr. Hafer explained the ESSA/Title Funds Consortium benefits with Esu10.
- f. The spring requisition process has been effective and efficient. Purchasing will be more typical this year due to the fact there are no large purchases related to teacher classroom supplies compared to last year's budget.
- g. Mr. Hafer explained the NDE recommended Standard Response Protocol (SRP) related to school safety. Information can be found at www.iloveyouguys.org. The board was reminded the school has a safety plan, processes, and procedures in place. However, the school is committed to continuous improvement related to school safety and is eager to implement the new SRP and begin staff development and training.
